

2021 MCC Accomplishments





- Due to Covid-19, most activities at the MCC stopped in March 2020 and have begun resuming in mid-2021.
- Zumba began classes outside in July 2020 and have since moved into the building following CDC guidelines. Classical Indian Dance classes resumed in September 2021.
- No in-person meetings were held at the MCC until September 2021, when the Girl Scouts and Friends of Bridgewater History returned.
- Facility Rentals private rentals are slowly beginning to pickup again.

2021 Trustee Projects

- Only emergency repair projects were undertaken in 2021 in an effort to minimize the financial impact of lost revenue.
- On 9/1/21, Hurricane Ida flooded the Washington Valley Library. Fortunately the books were not impacted but the rug was ruined. A new, vinylplank floor has been installed and looks great.









Treasurer's Report

2021 was another challenging year for the MCC with regards to finances. When the coronavirus hit in March 2020, the MCC and library followed state and local guidelines and closed their doors. The revenue for 2020 and 2021 was well below the projections. However, due to careful management of funds, the MCC has been able to continue to operate. Limited activities have resumed while remaining compliant with COVID-19 regulations.
